*Abstract of the Will of Lewis Richard of Gerddubluog in the Parish of Llanfair-juxta-Harlech in the County of Merioneth, Gentleman, written 25 Sep 1797, proved 30 Dec 1809, probate granted 7 Feb 1810.*

Refers to an Indenture of Lease and Release dated 28 Jul 1797 and 29 Jul 1797 respectively, being in twelve parts between the Reverend William Anwyl, Rector of Ashley in the county of Stafford, Clerk, eldest son and heir of Thomas Lloyd Anwyl late of Shrewsbury in the county of Salop, money scrivener, a bankrupt deceased, by Margaret Anwyl née Owen, now his widow, and Catherine Anwyl the wife of William Anwyl of the first part; the said Margaret Anwyl now of Aberystwith in the county of Cardigan of the second part; Margaret Anwyl of the same place, spinster, the only surviving younger child of Thomas Lloyd Anwyl by his widow the said Margaret of the third part; Samuel Pritchard of Meole Brace otherwise Brace Meole in county Salop, Gentleman, and Edward Tipton of Shrewsbury aforesaid, grocer, assignees of the estate, goods and effects of the said Thomas Lloyd Anwyl of the fourth part; Thomas Vaughan of Shrewsbury aforesaid, draper, and John Vaughan of the same place, mercer, Trustees of the said William Anwyl of the fifth part; David Anwyl of Llanyckil in county Merioneth, Gentleman, and Evan Owen of Festiniog in county Merioneth, Gentleman, also Trustees of the said William Anwyl of the sixth part; Robert Jeffreys of Shrewsbury aforesaid, Esquire, of the seventh part; Humphrey Jones of the town of Machynlleth in county Montgomery, Esquire, the Reverend David Davies of Penegoes in the same county, Clerk, and the Reverend Turner Edwards late of Oldport in county Salop but now of Broomhall in the same county, Clerk, the three aforesaid being the surviving Executors named in the last will and testament of John Edwards late of Machynlleth, Gentleman, deceased, of the eighth part; Susannah Edwards of Guilsfield in county Montgomery, widow and relict and sole Executrix named in the last will and testament of the Reverend Robert Edwards late of Machynlleth, Doctor in Divinity, deceased, of the ninth part; the said Lewis Richard and John Owen of Tyddynmawr in the parish of Trawsfynydd in county Merioneth, Gentleman, of the tenth part; Henry Roberts of Uchllawryrcoed in the parish of Llanenddwyn in county Merioneth, Gentleman, of the eleventh part; and Humphrey William of the town of Dolgelley in the same county, Gentleman, of the twelfth part. The Indenture refers to those messuages, tenements and lands called Hendreddwrgi in the parish of Llandanwg in county Merioneth, which were granted to the use of the said Lewis Richard and John Owen and their heirs and assigns.

Gives and devises the said messuages, lands and tenements to the use of **his wife Mary Richard otherwise Mary Griffith** her heirs and assigns forever.

Gives and bequeaths £10 to **his sister Gaynor wife of John William of Tyddu in the parish of Llangelynin in county Merioneth, farmer.**

All the rest of his personal estate, goods and chattels he gives and bequeaths to his said wife Mary Richard otherwise Mary Griffith, appointing her sole Executrix of his last will and testament.
