Abstract of the Will of Thomas Wynne of Cefn Cymmere in the Parish of Llanbedr in the County of Merioneth, written 13 May 1708, proved 17 Nov 1708.

He puts aside £20 for the use of the poor of the parish of Llanbedr, appointing his **eldest son Evan Wynne** to pay them once he reaches the age of twenty-one years. If Evan should die before attaining his majority, then he wills that **his second son William Wynne** shall pay them, and so on to **his youngest son Owen Wynne**.

He charges upon his eldest son and heir Evan Wynne eighty-five pounds to be paid [to his younger brothers] as follows:

- £20 to William Wynne
- £25 to **David Wynne**
- £20 to Owen Wynne

If Evan Wynne should die before reaching the age of twenty-one, he charges upon his second son William Wynne to pay the above amounts to his brothers, and so on.

Gives and bequeaths £9 per annum of rent charges out of Cefn Cymera as a jointure to **his wife Mary** for the term of her natural life.

Constitutes, makes & ordains his wife Mary sole executrix of his last will and testament.

Makes and ordains John Phillip and **his brother David Wynne** overseers.

Inventory taken the 11th day of July 1708 by William Edward, Henry Evan, David Griffith and William Meirick, his goods valued to £110.

From the Llanbedr Parish Register:

- Thomas son of Robert Wynne of Cefn Cymera was christened 19 Sep 1676 (*Thomas filius Roberti Wynne de Keven Kymere*)
- John son of Thomas Wynne and Mary his wife was christened 18 Oct 1696 (*Johannes filius Thomæ Wynne et Mariæ uxoris ejus*)
- William son of Thomas Wynne was christened 7 Feb 1701/2 (*Gulielmus filius Thomæ Wynne et uxoris ejus*)

- David son of Thomas Wynne was christened 21 Jan 1704/5 (*David filius Thomæ Wynne pleb' et uxoris ejus*)
- Owen son of Thomas Wynne was christened 23 Sep 1707 (*Owenus filius Thomæ Wynne et uxoris ejus*)
- Thomas's son John was buried 22 Mar 1707/8 (*Johannes filius Thomæ Wynne et uxoris ejus*)
- Thomas's son Owen was buried 8 Jun 1708 (*Owenus filius Thomæ Wynne et uxoris ejus*)
- Thomas Wynne de Cefn-Cymere was buried 24 Jun 1708
- Thomas's son David was buried 17 Feb 1709/10 (*David filius Thomæ Wynne et uxoris ejus*)
