

Kresen Kernow (formerly Cornwall Record Office), Reference: AP/J/1004

*Abstract of the Will of Richard Jolley of the Parish of St. Columb Major in the County of Cornwall, Innkeeper, written 22 Jan 1694/5, proved 3 Jun 1697.*

Gives 40 shillings to **his son Henery Jolley**.

Gives 40 shillings each to **his grandchildren Richard Lovell and Stephen Lovell**.

Gives to **his son-in-law Richard Lovell** his best great coat and best suit. The rest of his wearing apparel he gives to **Isaac Husband**.

Gives 20 shillings to **his daughter Barbara the wife of Edward Richard**, and 20 shillings to each of her children.

Gives 20 shillings to **his daughter Anne Bolythoe**, and 5 shillings to each of her children.

Gives twelve pence to each of his godchildren.

Gives to Mary Hixt and Mary Phillips two shillings sixpence each.

All the rest of his goods and chattels he gives to **his daughter Frances Webber** whom he appoints sole executrix of his last will and testament.

An inventory of the goods and chattels of Richard Jolley late of the parish of St. Columb Major in the county of Cornwall was taken and appraised on 2 Jun 1697 by James Cowling and William Tan? and valued to £26 10s.

The family name is variously written JOLLY, JOLLEY, JOLLYFFE, JOLIFFE.

Richard Jolley was christened in St. Columb Major on 13 Nov 1611, son of Alexander Joliffe and Barbara Oxnam. Richard Jollyffe married Frances Husband on 5 Oct 1641 in St. Columb Major.

*Counterpart lease in reversion, tenement in St Columb Major Churchtown, 3 Jun 1665.*

Parties:

- 1) Sir John Arundell of Lanherne
- 2) **Richard Jolley of St Columb Major**, husbandman.

Property: messuage and tenement late in the tenure and occupation of William Beauford, deceased, and formerly of John Rice, deceased, and now in the tenure of (2) in St Columb Major town.

Consideration £30.

Term: 99 years on the lives of party (2) and **his son Henry Jolley**, the term to commence on the death of William Beauford, son of William Beauford (deceased).

Rent (from the commencement of the term): 5 shillings yearly. One capon or 12 pence yearly. One harvest journey yearly or 6 pence. Heriot of one best beast on deaths of the two lives.

Covenants:

(2) to do common suit to the manor of St Columb, as the other tenants are accustomed, etc.

(2) to repair and maintain the property.
