

Prerogative Court of Canterbury and related Probate Jurisdictions: Will Registers, PROB 11/520/298.

Abstract of the Will of John Penneck of Tregimba in the Parish of St. Hilary and County of Cornwall, Gentleman, written 23 Sep 1709, proved 10 Apr 1711.

Gives to **his wife** his tenement of Tregimba Pedanpon and Hale Teague with Barnicutts tenement and all the tithe corn growing on the premises for the term of her natural life, having reserved it in the settlement of his estate made to **his eldest son John Penneck** on his marriage.

Also gives his wife all his household goods and stock on the land within the parish of St. Hilary, along with the £300 in his little study and any money in her chest of drawers.

Gives to his wife Nan Jenkyn *a/s.* Godolphin Mills with the adjoining stamps which, with her consent, is to be exchanged with **his son Francis Penneck** when he marries for Culvenn or Polasken, as well as half of the eighth part of Treleskan in the parishes of Cury and Mawgan.

Gives £500 to **his eldest son John Penneck**. Also gives to his son John and his heirs male the said fee simple estate of Tregimba. In default of issue, he gives the same to **his second son William Penneck**, and after him, to his grandson John Penneck. In default of issue male he gives the same to **Carew Penneck, the eldest son of his son William Penneck**. In default of issue, he wills the same to **his son Francis Penneck** and his heirs male; in default of issue, to **his son Charles Penneck** and his heirs male.

Gives £100 to **his son William Penneck**.

Gives £200 each to **his grandsons Carew and John Penneck, sons of his son William**.

Gives £100 to **his son Francis Penneck**.

Gives £100 to **his son Charles Penneck**.

Gives £800 to **his daughter Dorothy Penneck**.

Gives £800 to **his daughter Penelope Penneck**.

Gives £200 to **his daughter Mary the wife of Tobias Lanyon**, Gent, giving £20 each to her children.

Gives to **his son Francis Penneck** the reversion for one life in Hitchens [Kitchens?] tenement in Treslaw, along with his estate in Floods tenement.

Gives to **his son Charles Penneck** his estates in the tenements in Chereass, Trenwall, Herland and Trenerth. Additionally, he gives Charles his third part in George Blowings House, and the reversion of the present life on Namine *a/s.* Lamine tenement in Gwinear.

Gives to **his son-in-law Tobias Lanyon** the inheritance in fee simple of the tenement of Cuswyn Wolward in the parish of Gwinear.

Gives to **his son Charles Penneck** a dozen pewter platters, a dozen pewter plates, half a dozen brass pans, two brass crocks.

Gives to **his eldest son John Penneck** his biggest silver tankard, the biggest silver salt, and a dozen of the best silver spoons, which he will receive following the death of the testator's wife.

To the poor of St. Hilary, Marazion, Breage, Germoe and St. Mary's Island in Scilly, he gives 40 shillings each.

Gives 5 shillings each to his household servants.

All the rest of his goods &c he gives to **his sons John Penneck, William Penneck, Francis Penneck** and **Charles Penneck**, appointing them co-executors of his last will and testament, giving a conclusive vote to **his son-in-law Tobias Lanyon** should his executors disagree.

In a codicil to his will he forgives **his son-in-law Tobias Lanyon** a debt of £219 6s. 2d, on the condition he pays said amount equally between his children as they each come of age.
