

England & Wales, Prerogative Court of Canterbury Wills, 1384-1858, PROB 11/247/308.

The Will of Leonard Pethericke of the Parish of St. Stephen by Launceston in the County of Cornwall, Weaver, written 29 Aug 1653, proved 13 Feb 1654/5.

I Leonard Pithericke of St Stephens by Launceston in the County of Cornewall Weaver being sicke of Body (but perfect of memorie) Thankes be to God) Doe make and ordaine this my last Will and Testament in manner following.

First I doe give and bequeath unto **my wife Alice** that house and garden with thappurtenances which I hold by Lease from William Peprell; And the Tenemt called Cullveraltine and Stonie Stile during her life And alsoe the Moytie of Hoggserosse during her life. If the tearme soe longe indure I doe alsoe give unto my wife three Kyne

I doe alsoe give unto **my daughter Margaret Sampson** three kine And alsoe all my right and interest of and in one dwelling house and garden, called Lewes his house And the Courtladge and halfe the garden lyeing behind the said house And I doe likewise give unto her the said Margaret One quillett or little meddowe lyeing behind Rules house

I doe alsoe give unto **my daughter Jane the wife of Marke Saunders**, the house called the milkehouse; and the halfendeale of the Garden lyeing behind the same;

And my will is that **my sonne Phillip** shall have In evereleave and stony stile after the decease of my wife

I doe alsoe give unto **Marke Saunders my sonne in lawe**, my gray Colt; And one Cowe which is nowe att Tammtaton [Tamerton].

I doe give unto **my sonne Phillippe Pethericke**, One bay Colt, one brason Crocke, two puter dishes, and the great pann; And my will is that my said sonne Phillipp shall after the decease of **my wife Alice**, have halfe of the household goods,

I doe give unto all my Grandchildren x^s apiece.

I doe give unto **my daughter Julian Tuke** two Ewes

And further I doe give unto **my Sonne Phillip** my Loomes with the sleaes and takleing thereon to belonginge.

All the rest of my goods and Chattles not hereby given I doe give and bequeath unto **my wife Alice** whom I make my whole Executrix In Witness whereof I have hereunto sett my hand and seale, and published the same as my last will and Testament geven the xxviii day of August in the yeare of our lord One thousand sixe hundred fiftie three ;

This will was proved att London the Thirteenth day of February in the yeare of our lord God One thousand sixe hundred Fifty fower, Before the Judges for Probate of Wills and granting Administracons lawfully authorized By the oath of Alice Pethericke the relict and sole Executrix named in the said will To whom Administracion of all and singular the goods Chattells and debts of the said Deceased was Committed Shee being first sworne by Commission truly to Administer the same.
