The Will of Robert Rowland of the Parish of Marhamchurch in the County of Cornwall, Yeoman, written 27 Mar 1713, inventory taken 14 Apr 1713, will proved 23 Oct 1713.

In the name of God Amen the 27th of March 1713 I Robert Rowland of the parish of Marhamchurch and county of Cornwall being of a sound and perfect discerning minde and memory thanks be unto allmighty God doe make and ordaine this to be my last will and testament revoking all former wills by me made and is as followeth:

Impr.: I give and bequeath my soule unto allmighty God my maker and redeemer and my body to be buryed in Christian buryall according to the discession of my executrix hereafter named.

Item: I give and bequeath unto **Cidwell my wife** the estate Ginyers tenement untill my sonne John accomplishes the age of one and twenty yeares and after the said terme I doe give and bequeath the said tenement of Ginyers unto **my sonne John** and my will is that he shall pay unto **my sonne Richard** ten pounds within one yeare after he shall enioy the same and if **my sonne John** doe dye before he accomplishes the age of one and twenty yeares that then I doe give and bequeath the said estate of Ginyers unto **my sonne Richard** and my will is that **my sonne Richard** shall pay ten pounds within one yeare after he shall enjoy the said estate to be equally divided between the rest of my children which shall be then living.

It: I doe give and bequeath unto **my sonne Richard** six pounds to be payd him when he shall accomplish the age of one and twenty yeares.

Item: I give and bequeath to **my sonne Robert** fifteen poundes to be payd him when he shall accomplish the age of one and twenty yeares.

Item: I give and bequeath to **my sonne Nicholas** fifteen poundes to be payd him when he shall accomplish the age of one and twenty yeares.

Item: I give and bequeath to **my sonne William** fifteen poundes to be payd him when he shall accomplish the age of one and twenty yeares.

Item: I give and bequeath to **my daughter Joane** fifteen poundes to be payd her when she shall accomplish the age of one and twenty yeares.

Item: I give and bequeath to **my daughter Sidwell** fifteen poundes to be payd her when she shall accomplish the age of one and twenty yeares, and if any or either of my sayd children shall happen to dye before they accomplish the age of one and twenty yeares my will is that such chldes portion shall be equally divided between my son Richard and my sonne John.

Item: I doe make and ordaine **Richard Rowland and John Rowland my brother** and John Heddon and Christopher Juell to be Trustees for my children.

Item: All the rest of my goods and chattells not given nor bequeathed I give and bequeath unto **Cidwell my wife** whom I make and ordaine to be my whole and full executrix and to maintayne my children untill they accomplish the age of one and twenty yeares, and to see my will performed, my debts and expenses paid

An inventory of the goods and chattels of Robert Rowland of the parish of Marhamchurch in the county of Cornwall, yeoman, lately deceased, was taken 14 Apr 1713 by Thomas Uglow of Marhamchurch, yeoman, Simon Uglow of the same place, and Christopher Jewel of the same place, and valued at £144 10s.
