The Will of Isaac Garrett Senr. of Little Leighs in the County of Essex, farmer, written 10 Aug 1780, proved 13 Oct 1780.

I Isaac Garrett Senr. of the Parish of Little Leighs in the County of Essex, Farmer, being of Sound and Disposing Mind and Memory, Do make and Publish this my Last Will and Testament in manner and Form following — and First I Give and Resign my Soul into the Hands of Almighty God who gave it me and my Body I commend to the Earth to be decently Buried at the direction of my Executor after Named and as Touching such Worldly Effects wherewith it hath pleased God to Bless me with — I Give Devise Bequeath and Dispose of the same in manner as Follows. I Give unto **my son Isaac** all my Farming Stock together with all my Household Goods and Chattels Sum or Sums of Money Right or Credits, with all Bonds Bills Dues Book-Debts, of what Nature or kind soever they are, upon Consideration that my aforesaid Son Isaac shall pay or cause to be Paid out of the same the after mentioned Legacies that is to say unto **my son Edward** the Sum of Ten Pounds, also unto **my son Abraham** the sum of Four hundred Pounds, also unto **my son William** the like sum of Four Hundred Pounds to be paid to each of them Immediately after they arrive to the Age of Twenty and One and not before, my Will and Desire is that Margaret Lewis my House Keeper shall have all Her Just Wages as shall be Due to Her at my Decease. Likewise I Give and Bequeath for several Good Reasons unto the said Margaret Lewis the sum of Thirty Pounds to be paid her by my Executor Twelve Months after my Decease and I Do Nominate and appoint **my son Isaac & Margaret Lewis** my Sole Executors of this my Last Will and Testament hereby Revoking all Former Wills by me heretofore at any time Made and I Do Declare this to be my Last Will and Testament in Witness whereof I have Set my hand and Seal this Tenth Day of August in the year of our Lord one thousand Seven hundred and Eighty.

Signed, Sealed, Published, and Declared by the said Testator to be his Last Will and Testament in the Presence of us who have hereunto Signed our Names, as Witnesses in his Presence and at his Request.

This Will of Isaac Garrett late of the Parish of Little Leighs in the County of Essex deceased was Proved on the thirteenth Day of October in the year of our Lord one Thousand Seven Hundred and Eighty before the Reverend John Morgan, Clerk, — Surrogate... by the oath of Isaac Garrett Son of the deceased and one of the Executors (Power being reserved of making the like Grant to Margaret Lewis the other Executrix named in the said Will) to whom Administration of all and Singular the Goods Chattels and Credits of the said deceased was granted and committed on the twenty fifth Day of the same Month of October, he being first sworn duly to administer.
