

Prerogative Court of Canterbury and related Probate Jurisdictions: Will Registers, PROB 11/197/197.

Abstract of the Will of Sir Robert Jackson of the Burrough of Barwick-uppon-Tweede, Knight, written 15 Jan 1645/6, proved 6 Aug 1646.

Gives £300 out of his estates in Fenham and Morton to **Sir Peregrine Carey and his wife his daughter Mary**.

Gives and bequeaths to **his son-in-law George Payley esquire and his daughter Mary George's wife** all his lands and hereditaments in Holbourne and Brownehowse.

Notes that after the death of Sir Peregrine Carrey, his daughter married the 'worthy, faithful and honest gentleman' George Payler Esquire, to whom he gives and bequeaths after the death of his daughter George's wife all his lands, tenements &c. in Hensham and Morton.

Gives and bequeaths to his kinsman Mr John Sleigh present Mayor of Barwick one third part of his moiety of the Corn Tythe of Creswick in the County Palatine.

Gives and bequeaths to **his sister Mrs Jane Davenport, widow**, one third part of his moiety of the Corn Tythe of Chiswick in the County Palatine. After her death the said third descends to **his nephew the aforesaid John Sleigh**.

Gives and bequeaths £50 toward the erecting of a new church in the town of Barwick.

Gives and bequeaths £5 each to the children of **his brother Mr Stephen Jackson of Hesselrigg**.

Gives and bequeaths £5 each to the **children of his brother Thomas**, namely to **Margarett Cathbirts, widow**, and **Elinor the wife of John Borside?**, and to the children of **their sister Merrill late wife of Andrew White** £5 each.

Leaves £5 each to the **children of his sister Anne deceased**; that is to say, to **Robert Turvin junior, Miriam Brown, widow, Frances the wife of Stephen Jackson junior**, and **Elizabeth the wife of William Smith**.

Gives £5 each to **the children of his brother John Jackson** preacher late deceased; namely, to **Stephen Jackson, Andrew Jackson, David Jackson, Samuel Jackson, Elizabeth the wife of Mr Clerke, Deborah the wife of George Stanton of Alnwicke**.

Leaves £5 each to **the children of his cousin John Jackson** schoolmaster late deceased; namely **William Jackson, John Jackson, Job Jackson...**

Gives & bequeaths £40 to **his niece Margarett Walker** of Bassenden.

Gives & bequeaths to **his nephew Mr Thomas Bradforth** the house in Palline Street Barwick wherein one George Richardson now dwells.

Gives to his daughter Mary and to her husband his son-in-law George Payler Esq^r. the lease of his dwelling house in the Palline Barwick.

Makes bequests to his servants (largely illegible).

Constitutes and appoints his son-in-law George Payler Esqr and his daughter the Lady Mary Carey George's wife as joint executors of his last will and testament.
