Abstract of the Will of William Humfres of St. Olave Southwark in the County of Surrey, leatherdresser, written 5 Sep 1633, proved 20 Dec 1633.

Gives & bequeaths £600 to his daughter Elizabeth Tufflyn the wife of Richard Tufflyn*.

Gives & bequeaths £100 to his grandchild Katherine Moore.

Gives & bequeaths £100 to his grandchild Elizabeth Tufflyn.*

Gives & bequeaths £60 to his grandchild William Moore.

Gives & bequeaths £50 to his grandchild Thomas Moore.

Gives & bequeaths £50 to his grandchild Mary Tufflyn.

Gives & bequeaths £200 to **his son William Humphres**, and also his best feather bed saving one, and two pairs of sheets and a rug, and the silver bowl which he uses in his house.

Gives & bequeaths to **his sister-in-law Jane Hillwell** (or Sillwell) the £10 he loaned her.

Gives & bequeaths £100 to the church wardens of St. Olave in Southwark to be distributed among the poor of the parish...

Gives & bequeaths £5 to be distributed among the poor of the town of Ruthin in the county of Denbigh where he was born.

Gives & bequeaths 20 shillings to be distributed at the discretion of the churchwardens of St. Olave toward the marriage of four poor maids, 5 shillings each.

Gives & bequeaths £5 to his sister Katherine.

Gives & bequeaths £5 each to **his cousin Thomas ap Richard** and his two daughters.

Gives & bequeaths 40 shillings each to **his cousin Symon Loyd** and his wife to make them rings in remembrance of him.

Gives & bequeaths 40 shillings each to **his brother's daughters Mersula Humphres and Katherine Humphres**. He also gives, devises & bequeaths to his said nieces his houses and gardens in the town and parish of Ruthin aforesaid.

Gives & bequeaths 40 shillings to his friend Thomas Kynaston to make a ring in remembrance of him.

All the rest and residue of goods and chattels, household stuff, leases, plate, jewels, money, debts and other things he gives & bequeaths to his said daughter Elizabeth

Tufflin, nominating, ordaining and appointing her sole executrix of his last will and testament.

Ordains and desires that his son-in-law Richard Tufflyn and his friend Samuell Davies overseers, giving to them £4 each for their efforts.
