The Will of Richard Isted of the Parish of Nutfield in the County of Surrey, Yeoman, written 4 Jan 1562/3, proved 11 Jun 1563.

(Paragraphed)

In the name of god Amen In the yeare of our Lord [1562/3] the fourth daye of Januarie I Rychard Isted of the paryshe Nuttfeld wythin the Countie of Surry yeoman beyng of perfecte mynd and memorie do ordayne & make my laste wyll and testament yn manner and forme folowynge that ys to saye

Fyrste I bequethe my soule unto almightie god and my bodye to be buried in the churche yard of Nuttfield.

Secondarely I gyve unto <u>myne eldest sonne Thomas</u> one greate brasse pott and one old coffer one aker of wheate lyinge within the parishe of Blesynglie wythin a close called Netherlande.

Also I gyve unto my sonne John my oxen & two blacke stears wiche were very ---d. Also I gyve unto hym lyke wise bolse Yokes wayne wheles and farrowe with all suche ymplements

I lykewise I give unto hym a grey geldynge & a colte also I gyve unto hym the residue of the field of wheate before named? also I gyve unto hym three quarters of Also I gyve unto hym a fetherbed a bolster two blankets and a payre of sheetes. Also I gyve unto hym a long ladder. Also I gyve unto hym a newe coffer standynge yn the mayds chamber. Also I gyve unto John a [little] brasse potte two pewter platters one axe and a axe & a troughe ad---- Also I gyve unto hym a newe cawldron and a cople of augers? & three Iron wedges and my beste sythe In condicon

I wyll my sonne John yf he shall paye or cause to be payde unto my dacher Catheryne vili. xiiis. iiiid. at the daye of mariage or at the age of xxii yere olde yf she remayne unmaried so longe. Also I gyve unto her one hangyng kettell and also I gyve unto her a brasse panne & an old kettell unbound and five pewter platters and two pewter dyshes. Also I gyve unto her a coffer standynge yn my chamber with the lynnen Also I gyve unto her one payre of shetes beynge? there within the coffer.

Also I gyve unto my servante Thomas Alen one heefar bullocke of two yeare of age

Also I gyve unto my Docher Margrete the best she can choose

Also I gyve unto my Docher Joane sixe stone of chese

Also I gyve unto eahc of my godchildren viiid. a pece

Also I gyve unto the churche of Nutfeld xvid. Furthermore I wyll and gyve unto Annis
my wyffe all my godes unbequeathed and also do ordeyne and make her my full
executrix of this my laste wyll & testament and she to paye all my dettes and
legacies.
