

London, England, Wills and Probate, 1507-1858, DW/PA/5/1685/43.

The Will of John Sanders of the Parish of Horley in the County of Surrey, Yeoman, written 27 Dec 1684, proved 24 Apr 1685.

In the Name of God Amen The seven and Twentieth Day of December ano Domini 1684 and in the six and Thirtieth yeare of the Raigne of our soveraigne lord king Charles the second etc I John Sanders the elder of Horley in the Countie of Surrie yeman being sick and weak in body but of sound and perfect memorey praised be given to god for the same, and knoweing the Incertaintie of This life here on earth and being desirous to settell thinges in order doe make this my last Will and Testament in manar and and forme and forme [sic] following that is to say

first and principally I Commend my soule to Almighty god my Creator etc... and my body to the earth from whence it was Taken to be buried in Christian manar by my Executor hereafter named shall think Cnveneint and as tuche my such worldly esteate as the lord in mercy hath lent mee my mind will and meneing is the same shall be Inployed and bestowed as by this my Will is expressed and first I Revoke and make voided all other Willes and Testaments by me formerly mad and appoynt this onely to be my last Will and Testament and non other

Item. I doe give and bequeath unto Sarah Sanderes my loveing wife one feather beed and beedsteed with pillowes bolstares Cortaines valiantes and all other Thinges thereunto belonging and The Thurdes of all my land.

Item. I doe give and bequeath unto Sarah Beadell and Sarah Nash my Two granddaughters fiftie shillinges a peece to be paied unto Them within one yeare after my Decease.

Item. I doe give and bequeath unto my Eldest sonn William Sanderes all That my howse Tenement and bildeinges Twelve ackres of land therunto belonging lieing and being in the parish of Horley in the Countie of Surrie to be to my sonn William Sanderes his heires and assignes for Ever.

Item. I doe give and bequeath unto my youngest sonn Thomas Sanders all that my parcell of land Called by the name of Inhames or by aney other name or names Whatsoever it is Called or knowne by together with one barne and other bildeings standeing uppon the saied Inhames To be to my saied youngest sonne Thomas Sanderes and his heires and assignes for ever nevertheless my will and meneing is that my saied two sonnes William Sanderes and my sonne Thomas Sanderes shall equally paie all my detes and all morgages That is upon aney parte or parcell of my saied land Whatsoever my sonne William Sanderes to pay one halfe of my detes and the morgag and my sonne Thomas Sanderes to pay the other halfe of my debtes and one halfe of all such morgages so that everie severall parcell of my saied land shall be free to of my Two sonnes and I doe give my sonnes William Sanderes and my sonne Thomas Sanderes all the Rest of my goodes and Chattelles Whatsoever I have to be Equally devided between them both and I doe mak my Two aforesaid sones to be my full and whole executors and adminestratores of this my last Will and Testament payeing my funerall expences in

Wittnes whereof I have hereunto sett my hand and seall the day and year first above written.
