*The Will of Thomas Taylor of the Parish of Heathfield in the County of Sussex,
written 14 Aug 1575.*

In the name of God Amen the xiiijth daye of augeste a^o d^e 1575 I **Thomas Taylar of the parryshe of Hethfeld in the County of Sussex** & in the Dyoses of Chychester beyng seke in body but in good & parfet Rememberans thankes be onto god do ordene & make thes my laste Wyll & testement in maner & forme folowyng Fyrste I be Quayght my soull to Almyghty god and my Body to the eryth. Itm I geve onto the powre pepell of the parresh of hethfelde xi^s viii^d Itm I geve & Be quayght unto **John Taylar my sonne** fyve poundes Itm I geve & be Quayght unto **Thomas Taylar my sonne** five poundes Itm I gyve unto **Robard Taylar my sonne** xi^s Itm I geve & Be Quayght unto **Susanna my Dauthter** iiij^{li} Itm I geve unto **my Daughter Susanna** one flockbede one bolster the nexte beste one Coverlete the beste a payer of blancates one payer of shetes Itm I gyve & be quayght unto **Jone my Dauter** the beste Cassoke whyche was her mothers Itm I gyve & be quayght unto **Angnes my Douter** a Rusete Cassoke whyche was her mothers Itm I gyve & be quayght unto **Angnes Akerst** xx^s to be payde wyth in one yere after my desese & from that tyme untyl she Commyth to the Age of xx^{ti} yeres or elles the daye of her marege which shall ferste hapen that then my exsecouter to the lyver the sayde stoke? of xx^s wyth the in Crese ther of unto the sayde Agnes or her assynes Itm I gyve unto **Alles Taylar my goddouter** vi^s viii^d to be payde unto **her father Robard Taylar** wyth in one monte nexte after my Desese Itm I gyve & be quayght unto **Elyzabeth Taylar my goddouter** vi^s viii^d to be payde unto **John Taylar her father** wyth in one mont after my desese Itm I geve & be quayth unto **Thomas Taylar my sone** a flok bede a bolster a blancate a Coverlete a payre of shetes All the Reste of my goods not be quayth my dettes payd & my legases fulfellyd & my Wyll per formyde I geve unto **James Taylar my sone** home I make my Exsecouter of thes my laste Wyll & testamente & my wyll is that **my sone Rychard Taylar** shall have the garden Shepe of **my son James** untyll he Comyth to the Age xxith yers & my Wyll is that **Rychard & James** shall the ----mes to gethers untill he commyth to the Age a fore sayd Itm I ordene & make James A Rede my over sear of this my laste Wyll & testement & for Every Daye that he [letteth a bowte the well in any xii^d for hese paynes & hes Charges payde by my Exsecouter
