Abstract of the Will of Nicholas Humphrey of Trawsfynydd in the County of Merioneth, Gentleman, written 27 Jul 1771, proved 11 Aug 1775.

Gives and bequeaths to **his eldest son and heir apparent** his gun or fowling piece and also his silver tumbler.

Gives and bequeaths £40 to **his youngest son Griffith Humphreys** together with all his wearing apparel.

Gives and bequeaths £40 to **his eldest daughter Margaret Humphreys otherwise Hill**, and also all his right, title and interest in a leasehold house in the Village of Trawsfynŷdd where she now lives and which he built at his own expense for her.

After the decease of his said daughter Margaret he gives, devises and bequeaths the said leasehold house and its premises to the three daughters of **his late son William Humphreys** share and share alike.

Also gives and bequeaths to his said daughter Margaret Humphreys otherwise Hill his clock, case and other its appurtenances now standing in Hafodwen.

Gives and bequeaths £40 to his granddaughter Elizabeth Osborn (he thinks her name is), only child of his late daughter Dorothy Humphreys otherwise Osborn.

Gives and bequeaths £40 to his grandchildren the children of **his late daughter Jane Humphreys otherwise Oldfield**.

Gives and bequeaths an annuity of 40 shillings to his youngest daughter Elizabeth Humphreys now the wife of Griffith Evans, sadler, for her own separate use during the lifetime of her husband. If Elizabeth should outlive her husband, then in such case he orders and directs that Elizabeth receive £40 within three months of her husband's decease in lieu of the annuity. Otherwise, if Elizabeth predeceases her husband, then the said £40 shall be laid out at interest for the use and benefit of her children.

Gives and bequeaths , to his friends and relations Reverend Rice Anwyl, Clerk, now curate of Llanuwchllwyn, the Reverend Robert Roberts, Clerk, now chaplain to Watkin Wynne of ---las Esquire, and his daughter-in-law Ellin Roberts otherwise Humphreys, widow, nominating, constituting and appointing them Executors of his last will and testament, in Trust nevertheless for to and for the use and benefit of his three granddaughters and daughters of the said Ellin Roberts: Jane, Gwen and Elizabeth Humphreys.

Orders and directs that his eldest granddaughter Jane Humphreys shall have and be entitled to £10 more out of his personal estate before distribution be made to his said granddaughters Jane, Gwen and Elizabeth Humphreys.
