£5 each to her old servant John Rees, to Lewis Pugh of Penrhosebach in the parish

of Penegoes, to Jane the daughter of John Evan of Machynlleth, shoemaker, to Morgan Ellis of the same place, skinner...

2 guineas each to Elizabeth Hughes now of Cefn---- in the parish of Towyn, to John the son of Robert Lewis late of Machynlleth, shoemaker.

Leaves to **her nieces Mary Anwyl and Susanna Evans** all her household goods, linen, and farm , share and share alike.

Nominates and appoints her nephew Evan Anwyl of Llugwy in county Merioneth, Gent. sole executor of her last will and testament, to whom she leaves the rest & residue of her personal estate.
