The Will of Catherine Vaughan of Dolmelynlyn in Llanelltyd Merioneth, written 29 Dec 1718, proved 10 Aug 1758.

[Smudged in places. Paragraphed.]

In the Name of God Amen I Catherine Vaughan of Dolmelynlyn in the parish of Llanelltyd in the County of Merioneth wi[dow] being of sound and perfect sense and memory prayed be to God for the same, do make publish appoint ... and declare this my last Will and testament in manner foll (that is to say):

first I commend my soul into the [hands] of Almighty God my and my body to be [buried] --- [a couple of lines badly smudged] ---

[In the matter of my] temporall & worldly goods wherewith it hath pleased God to blesse me I Give devise & bequeath the same as follows:

I give and bequeath unto each of **my beloved daughters liveing viz. Elizabeth Vaughan of Vaner, Jane the wife of Lewis Owen of Waenfach, Anne the wife of [Robert LLOYD of] Ddu allt & Ellin the wife of Owen Tydder of Cefn rowen** [one] guinea being of the value of one & twenty shillings of money of Great Brittain.

Item. I give and bequeath unto **my Grand child Barbara Lloyd the daughter of David W^{ms}**. of [Brynllefrith] Merioneth Gent one Guinea of like coin & value

Item. I give and bequeath one Guinea more of like coin & value to be equally distributed between **my Grandchildren sons & daughters of my deceased son John Vaughan** share & share alike

Item. I give and bequeath one Guinea more of like coin & value to be equally distributed between **my Grandchildren William and Griffith the sons of Lewis Anwill of Hengae Gent.**

Item. I give and bequeath all & singular the rest and residue of my goods cattle chattells and personall estate whatsoever and wheresoever moveable & immoveable unto **my well beloved son Robert Vaughan** whome I do hereby nominate constitute ordain and appoint sole Executor of this my last Will and testament hereby revoakeing annulling & makeing void all former Will or Wills by me heretofore made and ratifying and confirming this only as my last Will and testament.

Witnesse Whereof I the said Catherine Vaughan have hereunto set my hand & sale the Nine and twentyeth day of December in the year ... 1718.
